## **NRM Regions Australia Update**

NRM RA, our national representative body, plays a similar role to Vic Catchments at a national level. Alice Knight represents Victoria on the NRM RA Board, while our Executive Officer provides support at an operational level. We also have several CMA representatives on NRM RA communities of practice where specific topics are

discussed by NRM group staff from across Australia.

#### **WaterAble**

Llewellyn Prain is the founder of WaterAble, the foundation she established to address the underrepresentation of people with a disability in the Water Industry.

Llewellyn has been involved in the Water Industry since 2015. She is now vision-impaired but for most of her life, had

normal vision. One of the things she has found most difficult to come to terms with, is not the loss of her sight, but other people's attitude to it. People see the disability before the person. This is why she established WaterAble. While the Water Industry has some good inclusion initiatives, she feels disability is often seen as too difficult.

WaterAble is a network for people in the Victorian Water Industry who have a disability or who would like to show their support for disability-inclusion in the Industry. It aims to provide resources, raise awareness and offer support.

The foundation conducts speaking engagements to debunk misconceptions and highlight unconscious bias against disability. Their flagship program is the Connections program which matches people with a disability to Industry leaders in "matched pairs".

Llewellyn encouraged CMAs to start talking about disability in their organisations, to 'keep it simple and do-able' but just get some runs on the board.

Vic Catchments' supports WaterAble's practical approach. We encourage our CMAs and others in the Water sector to reach out to Llewellyn and **learn more...** 



### **Camping on Crown Frontages**

Will Guthrie from DELWP updated the Forum on the progress of the Camping on Crown Frontages regulations which are due to be implemented on September 1.

The approach that is being adopted is to only allow camping in areas that have been through a DELWP and cultural heritage assessment process and have been formally designated as areas for camping.



As this is such a large task, the focus will initially be in three areas in Northern Victoria, including the Goulburn, Ovens, Campaspe, Loddon and Broken rivers. The rolling program of assessments will continue over the next 6-12 months.

CMAs can play a role in identifying areas that they think are appropriate for camping.

Helen Vaughan spoke to the Forum about the Insight - Executive Leadership for Women In Water program, and the review that had taken place. DELWP looks forward to supporting the continuation of the program with a focus on women that are currently in executive roles. # **DELWP Update**

With Karen Lau now Acting Deputy Secretary, Environment and Climate Change, Amber Clarke (left) is currently filling in for her as Executive Director, Catchments, Waterways, Cities and Towns. We wish Karen well in her new role and look forward to keeping in touch.

Amber announced first round funding for EC5 programs was now being distributed with second round funding to follow soon.



Introductory meetings have begun with Traditional Owners with respect to renewal of the Vic Waterway Management Strategy.



# Partnerships and collaboration

Vic Catchments is a point of contact for industry stakeholders seeking support and input.



### **Deakin University**

Vic Catchments facilitated funding from multiple agencies to support Deakin University's Blue Carbon Lab prepare and submit an Expression of Interest 'Teal Carbon Methodology (inland waterways)' to the Clean Energy Regulator (CER). The submission proposed the development of 2 Teal Carbon Emissions Reduction Fund methods, one related to farm dams and one for wetlands.

If successful, funding will be provided by the CER for the development of the methodologies. These methodologies will be a big step forward in supporting land managers and the CMAs in the delivery of work restoring and protecting wetlands and supporting the management of farm dams for multiple values.

The partnership came about as a result of a long standing relationship with Blue Carbon Lab including work on Blue Carbon, investment by individual CMAs into Deakin Uni's data collection efforts and building on Vic Catchments' work with Blue Carbon Lab including the 2016 report Carbon sequestration by Victorian inland wetlands.





#### Landcare

We have recently renewed our MOU with Landcare Victoria Inc (LVI) and we met with their new Chair, Jane Carney and CEO, Andrew Maclean, in early August.

Numerous topics were discussed, including Regional Waterway Strategy renewal, the National Landcare Program review, camping on Crown frontages and the desire for LVI to develop a Landcare Plan for Victoria.

#### **VEWH**

We continue to build our relationship with the Victorian Environmental Water Holder (VEWH) and will be looking to review our MOU.

We have discussed opportunities to collaborate, including Sustainable Waterway Strategies and the Victorian Waterway Management Strategy.

#### **MAV**

We met with Municipal Association of Victoria President, David Clarke and Manager, Built and National Environment, Claire Dunn. Some of the topics discussed included:

- Planning and development
- Floodplain management
- Climate change adaptation and mitigation
- The protection of our natural resources such as water and biodiversity
- Community engagement.

We agreed to have further discussions, particularly about how we might work with DELWP on efficiencies in planning processes.
