Message from the Chair

Since October many of our regions have been heavily focussed on flood recovery. There has been widespread impact to people, properties, businesses, and the environment both directly and indirectly. CMA regions that have been impacted by floods, have been funded by the Victorian Government to deliver recovery efforts for this financial year and we await announcements about future recovery funding. It will be an ongoing effort and we will also need to carefully monitor our waterways for any lingering issues such as water quality and carp proliferation. We will also be feeding into the Victorian Parliamentary Inquiry to assist with continual improvement efforts.

Since we last met we have had new Ministers sworn in and DELWP is no more and DEECA has been established. With the inclusion of agriculture there is another opportunity for us to think about how integrated catchment management can be supported by the machinery of government. All CMAs have

CMAs and Melbourne Water (MW) have also been busy submitting their applications to the new round of National Heritage Trust (NHT) funding made available by the Australian Government. This is an important piece of work that compliments the investment provided by the Victorian Government.



The CMAs have a strong track record of delivery and governance and have put forward a strong case for why it is important to deliver this program through the regional NRM model and why Victoria should receive its fair share of funding.

Our February meeting was online, and we are in the process of establishing a process to identify big strategic issues that we will tackle collectively. More detail about our meeting is included in the report below.

Vic Catchments Meeting

Our February meeting was held online on 24th February. The next meeting is scheduled to be face-to-face on Thursday 18th of May 2023. Our 2023 meeting schedule is included later in Communiqué.

Commissioner for Environmental Sustainability (CES)



Dr Gillian Sparkes, Commissioner (left) and Dr Scott Rawlings presented on the status of the State of the Environment report for 2023. This is part of ongoing communication between Vic Catchments and CES in recognition of CMAs and MW as partners in the reporting process.

Gillian told the meeting delivery of the State of the Environment (SoE) report is on track. Of note to CMAs is that while the SoE 2018 reported against 170 indicators, and they will provide the baseline on condition and trend, the 2023 themes have been altered due to the establishment of standalone reports such as the Marine and Coastal Environment Report. Environmental water includes a draft framework

for future reporting in response to action 3.6 of the Water Plan.

This is the first report since the VCMC and the Catchment Condition Management Report were repealed from the CaLP Act. A catchment report within the SoE report will remove duplication and CMAs have developed material to inform this component of the report.

NRM RA Update – CEO, Kate Andrews

Kate provided an update on her work on influencing government and the private sector and the work NRM RA have been doing to inform members.

Influencing government and the private sector:

 the new Government came in with an agenda they want to address quickly – foremost being the Nature Repair Bill. Minister Plibersek is keen to get the private sector to put more money into these activities. Kate has run a couple of sessions for NRMers about the draft bill and NRM RA have contracted additional legal expertise so they can be properly informed in their submission.



 Environmental Protection Biodiversity Conservation Act Reform (National Environmental Standards) – Kate has been asked to provide advice on the Regional Planning portion of this part of the reform agenda and will keep us informed as it progresses.

NRM RA have released some work from experts in this space and are working with others to develop some overview papers and online workshops. As always, we were grateful to receive our quarterly update from DEECA.

Machinery of government changes have taken place within the department, now titled Department of Energy, Environment and Climate Action (DEECA). Minister Stitt (pictured right) as Minister for the Environment is being fully briefed on her new portfolio. Minister Shing continues as Minister for Water and Minister D'Ambrosio is Minister for Climate Action, and Minister for Energy and Resources.



Many CMAs have received funding for flood recovery activity around waterways for this financial year and a business case is being prepared for future years.

Following on from the *My Victorian Waterway* survey, DEECA is developing a discussion starter, which they will test with CEOs and Waterway Managers forums, to assist in the development of the Victorian Waterway Management Strategy.

We were also provided an update on Water is Life (WIL). CMAs are encouraged to read the document and inform themselves of who has been assigned as the accountable executive or senior officer for actions in WIL.
