Message from the Chair

It's been another busy period for our CMAs. The east of the state has again experienced the extremes of our climate with fires and floods impacting some of our regions. East Gippsland encountered fires and floods in one day! Other parts of the state are in full swing with hay and crops being harvested. We hope that the weather behaves itself.

At the beginning of October, we had the appointment of new Board members to our CMAs, including two new Chairs in Sarah Parker (GBCMA) and Euan Ferguson (NCCMA). We welcome them to Vic Catchments. We also welcome two new CEOs in Amber Clarke (CCMA) and Bec Hemming (EGCMA). With the inclusion of Amber and Bec, we now have more females than males in our CEOs cohort – a first for CMAs.

Our Chairs and CEOs have been busy, with the Chairs participating in the National NRM Chairs Forum (online) and the CEOs attending their forum in Canberra in November. Both were an opportunity to engage with Federal Ministers and Departmental staff as our CMAs work through their National Heritage Trust Project proposals with the government.

Our Chairs and CEOs also gathered in November for our most recent Vic Catchments meeting and to present our state-wide strategic directions to DEECA staff, with the support of our Executive Officer, Tony Baker.



We are now turning our attention to supporting DEECA in the development of funding proposals under the Victorian Environmental Contribution fund. We will be providing evidence of our delivery of the previous program and the value of investing in CMAs.

As we come to the end of 2023, I would like to make mention of the significant efforts of our Boards and staff from our CMAs. Like the 25 years preceding 2023, we continue to work hand in hand with our regional communities to improve the liveability of our regions.

I hope that you all have a safe and happy festive season and I look forward to seeing you in 2024.

Vic Catchments Meeting

It was pleasing to get together as a group with a face-to-face meeting in November. Our next meeting is scheduled for the 23rd February and will be online. Our 2024 calendar has been finalised and is located at the end of the Communiqué.

DEECA - Water and Catchments

We were grateful that Acting Deputy Secretary, Andrew Fennessy, and Acting Executive Director, Bryony Grice, could join the forum.



Andrew advised that Melinda Knapp has been appointed the new Executive Director of Water and Catchments, effective 4

December. Melinda has a long background in the public sector and over 20 years' experience in the Victorian Water sector. Vic Catchments will welcome Melinda at our February meeting. Andrew also informed us that a recruitment process had begun for the vacant Deputy Secretary position.

Andrew thanked those who had participated in the Parliamentary Inquiry into the 2023 floods, both as witnesses and those who had worked on preparation for it. He felt the Water sector had presented a very positive image of how it manages floods and how it might learn from last year's events going forward.

Bryony explained that the department is very busy with preparations for EC6 and thanked CMAs for their teams' input to the bids, which meant they could put forward the most compelling argument for funding.

Bryony outlined the process for renewing the Victorian Waterway Management Strategy, which is now 10 years old, and is core to the work of CMAs. A discussion starter in July was followed by six weeks of consultation, including the *My Victorian Waterways* survey. A detailed feedback session was held with the CMA CEOs Forum and more engagement forums with peak bodies and regional partners will begin in the New Year.

Landcare Victoria

We received an exciting update from Jane Carney (Chair) and Claire Hetzel (Acting CEO) on the launch of Landcare Victoria's *Landcare Plan*, on the 20th of November. This is the first plan of its kind for Landcare in Victoria, and it is significant to have a clear mandate from the Landcare community on what its priorities are – the result of a two-year listening process.



Jane and Claire explained that the context in which Landcare operates has changed significantly since its formation in 1986 and with government support unlikely to grow at the scale required, the plan calls for support and collaboration with key partners to achieve its goals. The relationship between Landcare and CMAs is more important than ever and Landcare will be looking at breathing new life into the MOU with Vic Catchments to support collaborative action.

NRM Regions Australia

Kate Andrews, CEO, joined the meeting online to report on current and recent activities of NRM RA including the National Chairs Forum (online) and National CEOs Forum (Canberra).



She felt it was a very encouraging sign that Minister Plibersek, Minister Watt and Assistant Minister McAlister participated in the forum.

Kate explained that NRM RA were heavily involved in the discussion around the Nature Positive legislation and are providing input about how NRM Groups and regional planning can add value to it

Commissioner for Environmental Sustainability (CES)

Commissioner Gillian Sparkes and Scott Rawlings (Director, Science and Reporting) provided an 'entrée' to the State of the Environment (SoE) 2023 report. The Report has been sent to the Minister but has not yet been tabled, so detailed findings could not be discussed. This is the fifth year of the 5-year reporting process and the first since the repealing of the Catchment Condition and Management report and the Victorian Catchment



Management Council (VCMC). The report builds on the approach, findings and recommendations of the SoE 2018.

Gillian said engagement with Vic Catchments, CMAs and Melbourne Water has been critical to the development of the report, and CES have found it a very worthwhile process. She hoped CMAs had a similar response and thanked CMA teams for their contributions.

Over half of the 139 SoE indicators relate to catchment condition, so it is highly relevant information for CMAs. Gillian explained the structure of the report and how the Indicator Assessment Dashboard provides a high-level overview. A dedicated website will go live with the data as soon as the report is tabled and she encouraged everyone to have a look at it.

The forum suggested there was an opportunity to link the work of the SoE with the CMAs' Outcomes Framework, thereby working together to fulfil the two sets of obligations. Gillian commented that part of the DNA of CES is to make sure the work they do is useful to the work CMAs do.

Tony Baker, our Executive Officer, attended DEECA's (Ag Vic) Biosecurity Strategy Implementation workshop on the 19th of September. The objectives of the workshop were to:



- Confirm what implementation success looks like for each of the five strategic goals.
- Establish priorities for focusing implementation efforts over the next 12-18 months.
- Committing to 'ways of working' that will underpin effective partnerships for implementation.

We discussed the value of regional planning, including the work that has already been done by CMAs to plan for biosecurity at a local level. We have been invited to attend the Victorian Biosecurity Round Table on the 29th and 30th of November.

Recent executive roles include acting as the Community Recovery Coordinator for the 2019/20 Northern NSW Bushfires; for the March 2018 Tathra (NSW) bushfire recovery and Recovery Coordinator for the April 2017 Northern Rivers (NSW) floods. In 2017, Euan was appointed Special Inquirer into the January 2016 Waroona (W.A.) bushfire which re-framed rural fire management in W.A.

Euan is a former Vice President of the International Association of Wildland Fire; a Director on the North East (Vic) Catchment Management Authority and Chair of NECMA's Audit and Risk Committee; a former Co-Chair of the University of Melbourne's Centre for Disaster Management and Public Safety International Liaison Committee. Euan is a Registered Forestry Professional and sits on Forestry Australia's Forest Fire Management Committee.
